DECLARATION OF COMMITMENTS

Protect the safety and health of all direct collaborators and contractors, regardless of their contracting method, identifying hazards, evaluating and assessing risks, and establishing controls that contribute to the generation of safe and healthy working conditions for the prevention of work-related injuries, illnesses and ill health.
