## PURPOSE

To establish the commitments to advance business operations with excellence and value generation, within the framework of respect for Human Rights, the Sustainable Development Goals, and the trust of our stakeholders.

## SCOPE

At Grupo Energía Bogotá, we commit that all of our business operations are within a sustainability setting, seeking balance between generation of value for our shareholders, well-being of communities and collaborators, and minimization of the environmental impact in the territories where we are.

For Grupo Energía Bogotá, sustainability is the ability to understand and manage its environment, innovate and adapt its businesses, making it profitable and giving benefits to the territory where it operates, with a long-term vision.

## **DECLARATION OF COMMITMENTS**

- **1.** To protect the safety and health of all direct partners and contractors, regardless of how they are hired, identifying hazards, assessing and evaluating risks, and establishing controls that contribute to the generation of safe and healthy working conditions to prevent injuries, diseases and work-related health deterioration.
- 2. To comply with the applicable legislation in environmental, social, occupational safety and health in the workplace management, as well as other requirements that companies from Grupo Energía Bogotá subscribe to.
- **3.** To early manage risks, impacts and opportunities that, under a precautionary principle, may be generated in environmental, social, and occupational safety and health matters as a result of our operation.
- **4.** To build up a genuine, timely and permanent relationship that strengthens trust with our stakeholders by promoting dialog and participation in a scenario that respects diversity and multiculturalism of the regions and countries where we are present.
- **5.** To contribute responsibly to the cultural and social development, and to the economic growth of the communities, with actions that bring measurable socio-economic and environmental benefits in the areas where we make presence.





- **6.** To manage strategic alliances with public, private and civil society actors who share goals of progress and well-being for the communities in order to have allies committed to competitiveness, equity, construction of public values such as democracy, peace building, human rights, the fight against corruption and respect for the environment.
- **7.** To promote research, development and innovation (R&D+i) that ensure growth and adaptation of our businesses to complex environments, and global trends and dynamics.
- **8.** To implement good practices and promote actions aimed at environmental protection, pollution prevention, and adaptation and mitigation of climate change in our operations.
- **9.** To take risks and opportunities associated with regularly provided products and services that meet applicable customer, legal, and regulatory requirements.
- **10.** To continuously improve the effectiveness of the management systems adopted by Grupo Energía Bogotá.
